CITC program

Habitat Choptank makes a significant number of owner-occupied home repairs every year, in addition to the new home builds we are known for. This is key to preserving neighborhoods and has become an important piece of our work. Roof repairs are an overwhelming need for homeowners in our service area who do not qualify for traditional financial services.

Habitat Choptank applied to the Department of Housing and Community Development's Community Investment Tax Credit (CITC) program and was accepted for our Helping Hands Revolving Loan Fund and roof repairs made possible through this program. Donors make monetary gifts to Habitat Choptank to help homeowners fund critical roof repairs, which in turn they pay back on a sliding scale, and the donor receives tax credits that can be claimed at tax return time.
