COVID-19 IMPACT ON HABITAT CHOPTANK



As we mentioned last week, where homes are completed and buyers are ready, we are renting to our home buyers while loan applications are pending. We are excited to report that, under this arrangement, one home buyer and her family have already moved into their forever home in St. Michaels and our above home buyer moved into his forever home this past weekend in Hurlock.

These efforts are made possible by supporters of Habitat Choptank and we thank you. Legislation contained in the recently passed federal CARES Act encourages donors to make tax deductible gifts in 2020 to charitable nonprofit organizations like Habitat Choptank. One of the changes enables Americans to deduct up to \$300 of cash contributions, even if they do not itemize on their return.

Another change increased the limitations on charitable contributions during 2020 for Americans who do itemize by suspending the 50 percent of adjusted gross income limitation.
